MALL USE PERMIT APPLICATION SOUTH SOUND CENTER

Capital Development Company (CDC), a Washington Corporation, DBA South Sound Shopping Center (SSC/The Center), is privately owned and has been developed to provide the general public with a modern, clean, comfortable and safe place to shop. The Center recognizes that from time to time various groups and individuals may desire to use appropriate places in the mall for activities which they deem to be of community interest. South Sound Center management reserves the right to take applications for and, after review thereof, determine if such activities proposed are consistent with the primary commercial use of the Center. The Center, after granting permission, will designate a specific area or areas of the mall for the applicant to use. These are available on a "first come, first serve basis". This application does not constitute actual consent to hold the event at the Center until a Special Event Agreement has been fully executed.

1. The applicant must apply at least thirty (30) days prior to intended use. The Center reserves the right to grant special permission to those who could not have provided the thirty (30) day notice;
2. The applicant agrees to indemnify and hold harmless the owners and tenants of the South Sound Center from any and all claims for death, personal injury and property damage (including reasonable attorney's fees and court costs arising from the use by the undersigned of the property of the Center);
3. Applicant's trash or garbage must be removed from the premises by the applicant. Maintaining a clean area is a must;
4. Applicant will not restrict the flow of traffic (pedestrian/vehicular) on said property;
5. Assigned locations may be changed to accommodate mall activities without prior notice by the Mall Management;
6. Capital Development Company and South Sound Center shall be an additional "named insured" and shall be indemnified, held harmless and defended by the Insurance of the activity. A Certificate of Insurance copy will be given to CDC;
7. The undersigned hereby requests permission to use the South Sound Center for and on behalf of the organization listed below. It is understood and agreed that the organization and person signing this application will be responsible for the above listed and the actual Special Event Agreement that follows after permission has been granted.
